**RULES:** 1. All dogs must be currently vaccinated for distemper, hepatitis, leptospirosis, parainfluenza, parvovirus, and rabies. Please bring your health certificates for verification. 3. All dogs must be kept on leash or crated except when working. 3. You must clean up after your dog. 4. Livestock injured while being worked by your dog must be paid for by the participant working at that time. 5. No tape recordings, video cameras, movie cameras, are allowed except by special permission by Jack Knox. 6. The content of the clinic is determined by the instructor and shall not be disputed during the clinic. Disputes regarding the clinic must be given to a board member in writing.

**HOTELS:** Super 8 Motel in Verona is close to the clinic but we don't know if they take dogs. Quality Inn & Suites on Cahill in Fitchburg is "pet friendly" and very close to the clinic site.
